with separate seating arrangements for VIPs, general public, media personnel measuring approx 210x120 sq. feet as shown in annexure-A including all arrangements like mattresses, cushions, white sheets, matting, chairs and tables as required, and all other arrangements required to be made to the satisfaction of Convenor-Teh Bajari & Technical Sub-Committees constituted for the same.

**Thus, the successful bidder shall be required to erect four structures viz. structure no. 1, 2, 3 and 4 out of which he shall be allowed to let out shops erected in Structure no. 1 and 2 including eatery shops.**

Successful bidder shall be permitted to rent out structure no-1, 2 to desirous traders and he shall be permitted to collect rent for the same. Subletting shall not be allowed failing to which, security of the successful bidder shall be forfeited.

The reserve price for the Tender shall be Rs. 75 lakhs.

The bidders shall be required to deposit Rs. 15 lakh as Earnest Money by way of Demand Draft or in A/C No- 33970250826 S.B.I. Chamba, IFSC Code SBIN0000626 through RTGS payable to SDO(C)-cum-Convenor Teh Bazari and Minjar Mela Committee. This amount shall be released to unsuccessful bidders, other than the second and third highest bidders, immediately after the tender is awarded in favour of the successful bidder.
